## **Board Meeting of the Evergreen Homeowner's Association**

November 14, 2013

President Gary Meyer called the meeting to order at 7:05 pm.

Present: Board members Gary Meyer, Sam Carlson, John Williams, Riki Anderson & Nancy Mitchell. Homeowner Jackie Schmiedlin was also present.

Motion was made & seconded to approve the minutes from the October 10, 2013, meeting as written.

Motion was made & seconded to approve the financial statements for October. As of October 31st, we have \$21,667.33 in Voyager checking and \$10,050.90 in Voyager CDs. We also have \$27,183.35 in savings earmarked for insurance and deductibles. Our expenses in October were \$20,897.46. Our net income was (\$13,668.84). As of October 31st we are owed \$4,381 in back dues & late fees.

## Old Business:

**Storm damage to 2064 13<sup>th</sup> Ave W** – Hoelz Construction reports job is 50% complete.

**Windows at 1272 Polk** –Hoelz Construction has made several attempts to contact the homeowner. Sam will ask for a written assessment.

Water faucet repair/replacement – Complete except for unit 2001 (Adam Girtz). Plumber recommended that valves on both sides of faucets should be repaired; cost per faucet estimated at \$600. Board will review.

## **New Business:**

**Rental Units-** Board is discussing a proposal to cap total rental units. \*\*Effective Immediately\*\* If you plan on renting your unit, please let the Board know.

**Bylaws/Covenants** – Board has been reviewing process for revisions and would like to form a committee of homeowners. More information after next month's meeting.
