Board Meeting of the Evergreen Homeowner's Association December 12, 2013

Motion was made & seconded to approve the financial statements for November. As of November 30th, we have \$25,899.89 in Voyager checking and \$10,050.90 in Voyager CDs. We also have \$27,183.35 in savings earmarked for insurance and deductibles. Our expenses in November were \$2,819.44. Our net income was \$4,288.56. As of November 30th, we are owed \$4,583 in back dues & late fees.

Old Business:

Storm damage to 2064 13th Ave W – Hoelz Construction will continue to work on this when temperature is above freezing.

Windows at 1272 Polk – Hoelz Construction submitted his assessment to HOA Board for review.

New Business:

Clearing mailboxes – Jerry's Lawn Service will be contacted to ensure they clear an appropriate area around the mailboxes.

Bylaws/Covenants –Interested homeowners are invited to a working session scheduled for Feb 15th, 9:30 am at 1276 S. Polk.

Garbage Contract- City of Shakopee has contracted with Allied Waste beginning June 1, 2014. Our current provider, Dick's Sanitation Inc. will be contacted to understand impact for our association.

Insurance Deductible- Our American Family agent has informed us that our deductible will be increased to \$2500 effective March 1, 2014. *Each homeowner should review this change with their insurance agent.*

The meeting adjourned at 8:00 pm.
